





# Formal Education

### Dear Members,

Thank you to everyone who has been able to join us the annual conference. It's was great to be back in person! As tragic as the Covid Pandemic was and continues to be, it forced us to climb out of our comfort zone and shift into a new way to conduct our education program which brought about a lot of positive changes.

Not only did we successfully create an online training program when others said it couldn't be done in such a short period of time, we have gotten raving reviews on the professionalism, quantity of the content & quality of the teaching method. This helped broadcast our ability and created a huge buzz within the licensing authorities around the state and helped us expand our partnerships with the 8<sup>th</sup>, 9<sup>th</sup>, 10<sup>th</sup>, 19<sup>th</sup> & 20<sup>th</sup> circuits. In 2021 alone, we put on a minimum of 36 online classes and taught several in person classes within the 15<sup>th</sup>, 19<sup>th</sup> & our newest addition, the 5<sup>th</sup> circuit where we are hoping to forge a permanent relationship.

All in all, we have had approximately 350 attendees at our education classes over the past year and generated just shy of \$42,000.00 in gross revenue for a net income over expenses of just over \$19,000.00 which of course, helps the association supplement other committees such as the Legislative Committee that doesn't have a revenue stream yet is one of the most important committee this association has to protect our members all the way down to our roots.

As of this moment, we already have 9 classes scheduled between March through August with 3 of them being in person including Orlando at the annual meeting, Indian River in April and Safety Harbor in June. As we get closer to August, additional classes will be scheduled to accommodate the 15<sup>th</sup>'s Circuit licensing renewal season. At least 2 or more classes a month from September through December will be added. Our full course schedule is available at www.fapps.org under the Education tab.



### A Smokey Situation





### \* BYLAW AMENDMENT APPROVED AT THE ANNUAL MEETING \*

The following Bylaw Amendment was approved by the membership at the annual meeting March 12, 2022.

Article VI, Section 5. No more than one person **two people** from the same immediate family or from the same firm may serve as an officer or director at the same time. The Administrator may not hold any Officer or Director position on the Board of Directors. (Amended **March 12, 2022**; March 10, 2012)

Dear Members,

The legislative committee has been very busy the last several months. Aside from working on our own FAPPS proposed Senate bill 750, we encountered another bill, HB 545 that was composed by a committee initiated by the Florida Bar. The initial bill first filed contained some alarming language that would have proven unfavorable to process servers in general, had they not been changed. We initiated several meetings between ourselves, with the bill writers, the sponsoring Representative, and others involved in this initiative to voice our concerns, opinions, and recommendations.

As the bill quickly moved to committee hearing, we felt the sense of urgency to initiate a stronger approach in person. At the advice of our lobbyist Jose Diaz and President Bob Musser, committee members Lance Randall, Diana Wardwell, and myself traveled to Tallahassee to meet with members of our Florida Senate and House of Representatives to again voice our concerns. Our voices were heard, and the bill was rewritten on the last evening which then included several changes we had requested. This bill HB545/ SB1062 has passed the three required committees so far as of the date of this report.

If this bill passes, it contains many changes pertaining mainly to service on business entities, as well as several other areas of Chapter 48. The effective date would become January 2023. As it stands now, the bill can be signed by the Governor, it can be vetoed by the Governor, or it can be left alone by the Governor, and it will become a passed law. Since it will likely become law, our FAPPS education team will be ready to teach process servers across the state the new material in their courses.

Unfortunately our own proposed bill SB750 has again "died in judiciary ". The process of having a bill passed is a difficult one, and even after being sponsored the last two years, we were simply left out with other prioritized bills. Future updates will follow.

# Thoughts - An Educational Forum Submitted by Dr. Denny Howley

### **FAPPS** and The Democratic Process

The democratic process is imperfect at best, but it is the best system of "government" we have come up with to date. The key to an EFFECTIVE democratic process, however, lies with an interested electorate who accepts the fundamental responsibility to carefully review the candidate for office and then vote to put those individuals into office who best represent them.

A fundamental problem of both the election process and the candidates themselves is our human nature...the greatest problem of which is our ego.

There is an old saying in the warrior class of the military - Lead, follow or get the hell out of the way.

### LEAD ...

Few of us are natural leaders. Few of us have the natural charisma that commands respect. Most of us just do the best we can with what we have and who we are. Nonetheless, Leadership is a skill and like any skill, it can be learned, if one is willing to take the time to do so.

### ...FOLLOW...

Few of us are good followers. We are much better at criticizing the action of others from the "side-lines".

### ...OR GET THE HELL OUT OF THE WAY.

Few of us are honest enough to admit we are not leaders or that we are poor followers, who prefer to criticize negatively even though we provide no "input" to the decision making process. Those of us that do so, become by our actions, a negative force that is divisive to the organization and undermines the leadership, complicating their already difficult job.

Democracy generally works, despite us and our non-involvement in the election process. But if we do not get involved, if we do not learn about our candidates and issues, then we have no grounds for either criticism or complaint.

We have copped out and chosen to let the fickled finger of fate do what it wishes...to us, to our lives, to our business' and to our future.

Democracy works, but there are some simple rules that can help maximize its effectiveness.

### 1. Be constructive- not disruptive

If you have a comment, suggestion, etc. – frame them in a positive manner to help the decision making process. Not all your comments will be acted upon, some will be rejected. But they will be reviewed and the elected officials will have to think on them. More importantly those you elect will know you are watching, interested and involved.

### 2. Be supportive

Help those you elect and others, "be all they can be" for the good of the organization and so they, as human beings, maximize their personal growth. Bite your tongue at their imperfections. Remember, just like us, they are only human. Focus on their positive points and strengths – not on their weakness'.

### 4. Do not get personal in your disagreements



Dear Members,

Please remember that safety is always a priority whether it is professionally or personally we want everyone to be safe and respectful to others while we are still navigating the uncertainty of all that is happening in our society.

As many of you know we have had an uptick in violent acts in the past few months, even more reason for you to be safe and aware of your surroundings at all times.

Updates for violent acts:

### **Active Cases:**

Pinellas County Incident Date: 7/21/2021:

The server was violently attacked after effectuating service. He needed immediate medical attention and has suffered injuries to his upper body and head. He required numerous stitches to his face. An arrest has been made and they are scheduled for a 2nfd pre-trial on 12/9/2021.

Polk County Date of Incident: 9/6/2021:

Server was attempting to serve a subject who was working in the yard and claims to have been threatened with a gun and gardening shears. Servee made threatening comments such as "Do you know how easily I could cut your throat?", the server has met with the Polk Sheriff's office and we are awaiting an update.

### Closed Cases:

Martin County Incident Date 7/20/2021:

The process server was pushed down a flight of stairs at a condo complex. (he was not injured) The husband of the person he was attempting to serve followed him to his car and slammed the papers on the servers windshield and busted the windshield. No arrest was made and the Sgt. Advised the server he did not have a case. The server requested that the report be referred to the State Attorney for review and they denied the request. The process server also filed a complaint against the officer, and he has not heard from the agency regarding any further action. He also called the State Attorney and their office advised they cannot follow up on the case unless the report has been filed by the agency who responded to the call.

As you see the VAPS committee has been busy. It is important to remember to report all cases of violence not only to local law enforcement but to the VAPS committee. Please submit any acts of violence on the FAPPS website <a href="https://www.fapps.org/ViolenceReport">https://www.fapps.org/ViolenceReport</a>, a member from the committee will follow up and provide general assistance with your case.


